## What is a grant for a 'Brilliant Marine Research Idea'?

VLIZ - Flanders Marine Institute - has become, over the last 20 years, a knowledge institution indispensable to the marine research landscape. What started as an institute focusing on science support, has evolved into a national and international point of contact for marine research. VLIZ initiates and carries out multidisciplinary research and supports marine experts by providing research infrastructure, data, information and knowledge. VLIZ supports the blue economy and reaches out to a broad public. VLIZ further broadens its marine horizons and aims at becoming a world player in the field of marine and coastal research.

In 2013, VLIZ was recognized as a charitable organization and therefore developed a philanthropy program. Through this program, VLIZ is able to raise additional funds through membership fees, donations, sponsorships, etc. to provide financial support to promote marine research worldwide. The Brilliant Marine Research Idea grants are offered by VLIZ philanthropy, named The Sea as a Good Cause, and receive additional sponsoring from **DEME** and from a **private donor**.

<u>DEME</u> (Euronext Brussels: DEME) is a leading contractor in the fields of offshore energy, environmental remediation, trenching and marine infrastructure. DEME also engages in concessions activities in offshore wind, marine infrastructure, green hydrogen, and deep-sea mineral harvesting. The company can build on more than 145 years of experience and is a front runner in innovation and new technologies. DEME's vision is to work towards a sustainable future by offering solutions for global challenges: a rising sea level, a growing population, the reduction of emissions, polluted rivers and soils and the scarcity of mineral resources. DEME can rely on about 5.000 highly skilled professionals and operates one of the largest and most technologically advanced fleets in the world.

The grant for a 'Brilliant Marine Research Idea' for predocs in the South is intended to inspire and enable PhD students working in a southern non-European country\* while having a strong connection to a Flemish Marine Research Group, a Flemish university or a Flemish university college by

- having obtained an international master's degree from a Flemish university\*\*, or
- having a doctoral grant, half awarded by a Flemish Marine Research Group or university combined with the financing of the other half by a partner institution or university in the South (so called "sandwich grant").

The grant serves to execute a brilliantidea during their PhD within the frame of their research. It should concern an out of the box idea, an additional research topic that was initially not foreseen in the PhD, but that would add an extra value to the ongoing research.

For 2023, **The Sea as a Good Cause** offers one grant to a predoc in the South for their 'Brilliant Marine Research Idea'. VLIZ philanthropy seeks to fund a marine research idea that can contribute to solving a hypothesis-based marine research question. Topics of interest are (amongst others and not limited to) the themes identified in the philanthropy research agenda including pollution, ocean and human health, marine biodiversity, climate change, ocean related disasters and marine explorations.

For 2023, VLIZ philanthropy has the honour to receive sponsoring for the 'Brilliant Marine Research Idea' grants from **DEME** and from **a private donor.** 

Framed within the area of interest of the company, DEME sponsors a BMRI grant for a research topic situated in a.o. engineering & technological sciences (including civil engineering), material sciences, economic sciences and biological sciences.

The **private donor** supports, according to their interest, one of the laureates selected by the VLIZ Scientific Committee.

The fund of maximum 5.000 EUR can be used to assist PhD students in lab and/or fieldwork, data acquisition and analysis, visits to other institutes to use specialized facilities, acquisition of equipment or software needed for a certain analysis and so on. The fund cannot be used to reimburse the use of existing lab infrastructure within his/her research group/department, for personnel costs, to pay for travel costs that amount to more than 50% of the grant or to attend conferences.



## **Budget and implementation period**

The overall budget available for the grants is 5.000 EUR from VLIZ philanthropy with the financial support of the sponsor DEME and of the private sponsor.

The grant will be awarded to the successful applicant personally and the terms and conditions (including a short report) of the award will be discussed and negotiated prior to the implementation of the idea.

The proposed idea has to be executed within one year. The selection of the ideas will take place before 23 February 2023. The successful applicants can start their activities from 1 March 2023 and complete them by 28 February 2024.

# Eligibility and selection criteria

## Eligibility of applicant

- PhD student with, at the time of application, less than 6 years of research experience at predoc level (i.e. since starting PhD research) working in a southern non-European country\*
- Having a strong demonstrable link with a Flemish Marine Research Group, Flemish university or a Flemish university college by having obtained an international master's degree from a Flemish university\*\* or having a doctoral grant, half awarded by a Flemish Marine Research Group or university combined with the financing of the other half by a partner institution or university in the South (so called "sandwich grant").
- Consent of the university (college) supervisor

## Eligibility of budget and implementation period

- Maximum request for 5.000 EUR
- Maximum duration of 1 year
- Implementation between 1 March 2023 and 28 February 2024

## Eligibility of activities and related costs

The grant (budget allocated by VLIZ) includes all possible university/institute 'overhead' or other costs, i.e. no additional will be accepted.

- The grant is used to finance local costs (within the country where the student runs his/her PhD research)
- No personnel costs
- No conference fees
- No reimbursement of the use of existing lab infrastructure within your research group or department
- Travel costs cannot amount to more than 50% of the grant
- The research topic should concern an out of the box idea, an additional research topic that was initially not foreseen in the PhD, but that would add an extra value to the ongoing research
- Recommended:
  - the research topic is unique and relevant for the country which is proved by publications
  - the research results in a strengthening of the collaboration with the connected Flemish Marine Research Group by e.g. contributing, to a database, a project, a publication, etc.

## Eligibility of research domain for the VLIZ philanthropy BMRI grant

Topics of interest are marine related and are (amongst others and not limited to) the themes identified in the philanthropy research agenda including pollution, ocean and human health, marine biodiversity, climate change, ocean related disasters and marine explorations.



## Eligibility of research domain for the BMRI grant sponsored by DEME

The eligible topics are marine related and fit within one of the following descriptions:

#### 1. Engineering and technological sciences (including civil engineering)

- Coastal engineering and hydrodynamics
- Nature inspired solutions for coastal management (protection)
- Nature inspired flood protection for rivers and estuaries
- Offshore (geotechnical) engineering sustainable scour protection

#### 2. Materials science

- Tunable biodegradable material in marine environment

#### 3. Economic sciences

- Nature Based Solutions business case bringing nature inspired solutions up to a mature business level
- Sustainability and economics

#### 4. Biology

- Effect sound on marine mammals offshore works
- Dunes: eolic sand transport and influence on dune management
- Offshore (oyster) reefs
- Biofacilitating structures
- Biobuilder species and (other) biogenic reefs

#### 5. Divers

- Multi-use of space / marine spatial planning
- Renewable energy / aquaculture / others
- Ammunition and toxic waste dump solutions
- Microplastics and ocean pollution solutions

### Eligibility of submission modalities

Timely and complete submission.

### **Selection procedure**

After the deadline has passed, the scientific board of VLIZ together with a representative of DEME will evaluate the submitted applications and make a final selection. The jury has the right to withhold the grants, if it decides that none of the proposed proposals can be taken into consideration.

All applicants will be personally informed about the success of their proposal.

The grants are awarded during the VLIZ Marine Science Day on 1 March 2023. Successful applicants will be invited to send in a short video as a way to present their work at the VLIZ Marine Science Day 2024.



# How to submit an application?

Applicants can apply for the grant by sending **following documents** to <u>filantropie@vliz.be</u>:

- application form
- cv of the PhD student
- letter of consent of the supervisor affiliated to the student's university or university college (free format)
- recommendation letter of the scientist with whom the student is strongly connected at a Flemish Marine Research Group, a Flemish university or a Flemish university college (free format)
- a copy of your international master's degree from a Flemish university or prove of your doctoral grant, half awarded by a Flemish Marine Research Group or university combined with the financing of the other half by a partner institution or university in the South.
- optional: a copy of your PhD proposal, to proof the add-on value of your BMRI proposal

Submission deadline: No later than 27 January 2023
